1 RUNWAYS AND ASSOCIATED EQUIPMENT

1.1 Runway 07 and 25, subject to serviceability of the required facilities, are approved for Category II operations.

2 CRITERIA FOR THE INITIATION AND TERMINATION OF LVP

- 2.1 Low Visibility Procedures will be activated when RVR is less than 550M and not less than 300M and/or cloud ceiling is less than 200FT but not less than 100FT.
- 2.2 Pilots will be informed when these procedures are in operation by ATIS and/or by RTF.

3 GROUND MOVEMENT

- 3.1 All Runway 07 departures will be via Holding Point Delta 1 only, and all landing aircraft may vacate the runway via Holding Points Delta 6, or Delta 7, or Delta 8.
- 3.2 All Runway 25 departures will be via Holding Point Delta 8 only, and all landing aircraft may vacate the runway via Holding Points Delta 3, or Delta 2 or Delta 1.
- 3.3 Taxiway stop bars will be used to reinforce taxi clearance limits.
- 3.4 Pilots are advised that crossing illuminated stop bars on the manoeuvring area is strictly prohibited.

3.5 Aircraft taxiing to or from the south aprons may still use Echo 2 and Echo 7.

4 DESCRIPTION OF LVP

4.1 During Cat II operations, special ATC Low Visibility Procedures will be applied.

5 CANCELLATION

5.1 This AIP Supplement will remain until the relevant contents are incorporated into Oman AIP.
