Flight Synthetic Training Device (FSTD) Acceptance Application Form

CAR ORA Article 5 - Flight Simulation Training Devices.

- (a) Flight simulation training devices (FSTDs) used for pilot training, testing and checking, with the exception of developmental training devices used for flight test training, shall comply with the technical requirements laid down in this Regulation and shall be qualified.
- (b) The CAA may accept FSTD qualifications issued by a foreign state provided that:
 - (1) The FSTD operator was required to comply with equivalent technical requirements laid down in this Regulation; and
 - (2) The FSTD was evaluated against an equivalent technical standard required by this Regulation; and
 - (3) The access has been granted to CAA as per this Regulation; and
 - (4) The operator complies with the conditions or limitations set out in the acceptance by the CAA.
